On 31/03/2024 the member of the Society was 3,42,656 During the reporting year 60,805 new members were admitted however due to death and resignation 2,396 members were reduced. As on 31.03.2025 the total members of the Society are 4,01,065 The increse is 17.05%.

### **Share Capital**

The Authorized share Capital of the society is Rs. 100,00,00,000 and the paid-up share capital as on 31/03/2024 was Rs. 88,61,98,200. There has been an increase in the share capital of Rs. 7,60,87,100 in this financial year. Due to the large amount of debt accounts being closed in this financial year, the member share capital amount attached the loan account was withdrawn. The organization has focused on secured gold secure loans during this financial year. More than 250 crore gold secure loan have been disbursed during this financial year. In gold mortgage loan, the member share capital amount is only Rs. 100. The collected share capitals on 31/03/25 is Rs. 87,52,89,600 the decrease ratio is -1.23%.

### Recovery

During the Reporting year the Society has made vigorous efforts to control the Recovery of overdue amounts. In this financial year the Society has made remarkable recovery of category wise loans and advances through well organized recovery plan. Without resorting to Legal Procedures, the Society is giving priority to loan recoveries through reminders and direct visit to defaulters. Nevertheless, the legal methods have to be adopted under compulsion wherever necessary. As on 31.03.2025, the Society has disbursed Loans and Advances for Rs. 2078,77,72,146/-. As on 31.03.2025, there are 287 cases under section 138 pending the Court and Legal notices were served to defaulters. Hence we appeal to the defaulters to make regular payment of their dues and help in the progress of the Society

## Financially Strong & Secured Society i.e. CRAR (Capital to Risk Assets Ratio)

In Banking Business, the Deposits are liabilities & Advances are Assets. Hence while deploying the deposits in advance; the Society has prime consideration that the Advances should be performing.

For all round development, the Society had a formula planning in collection of Deposits and Disbursement of Advances, through a Time Bound Development Plan, prepared by the Management, to obtain effective recovery & to disburse the Advances to members having repayment capacity & experience. This has helped the Society to Control its NPA and increased income, there by achieving CRAR at 9.04%. This establishes that the Society is Financially Strong & Protected. As per RBI Norms, the CRAR adequacy should be 9%, the higher the CRAR, Stronger is the position of Institution.
